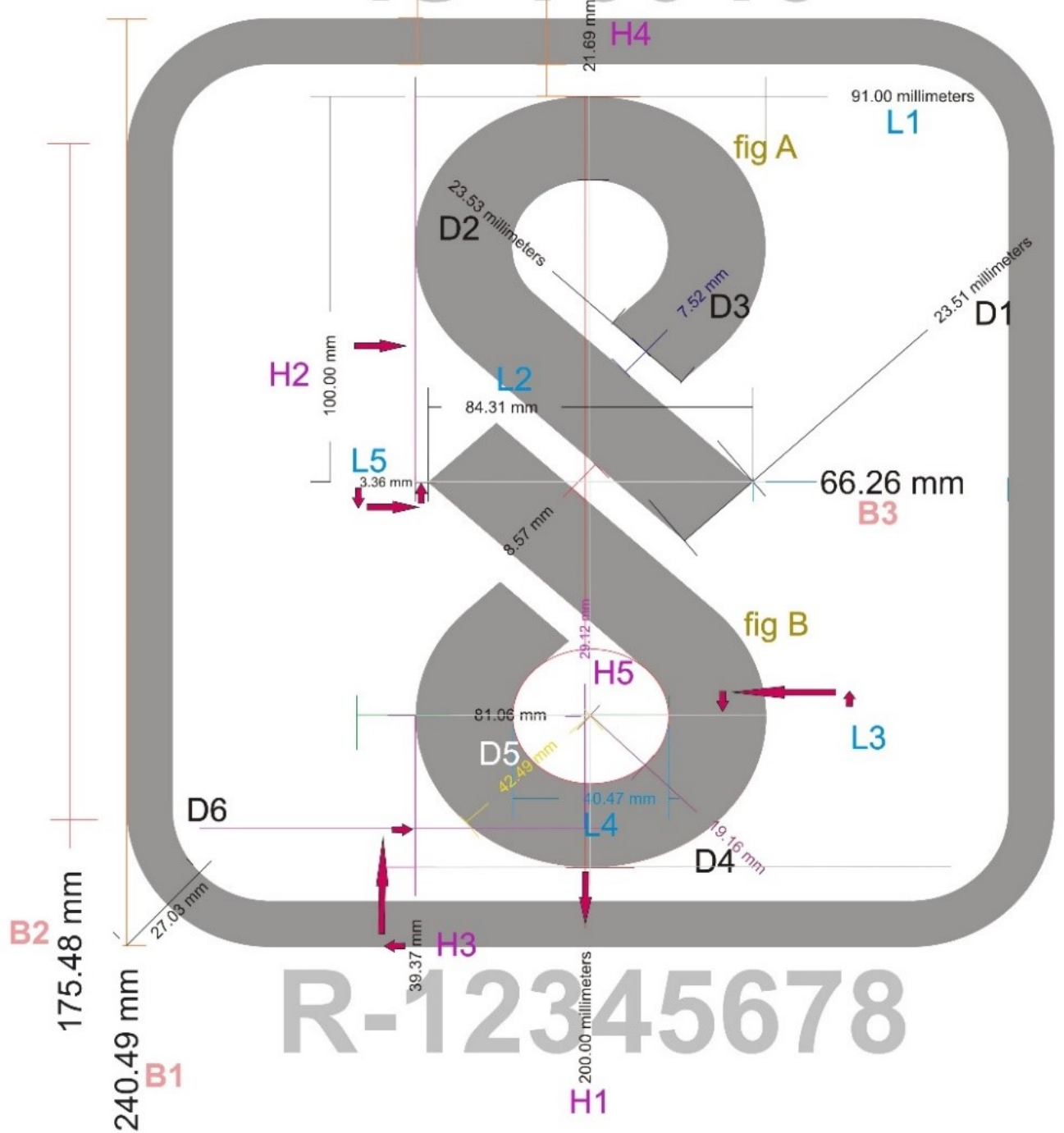
Annex - 1

- i) The monogram of the 'Standard Mark' consists of the pictorial representation, drawn in the exact style as indicated in the figure in the figure. Reduction and enlargement is permitted.
- ii) The 'Standard Mark' can be displayed in single colour or multi-colour as per the details given below. The colour scheme for the Standard Mark shall be used as indicated below.
- iii) The licensee shall display the 'Standard Mark' on the article and/or the packaging, as the case may be, in a manner so as to be easily visible and non-removable. Further, the durability of marking shall be as per the provisions of the relevant Indian Standard, wherever applicable. The registration number and words shall not be less than Arial font size 6.
- iv) Any device with an integrated display screen may present the Standard Mark electronically (e-labelling) in lieu of a physical presentation.

For multicolour Standard Mark the colour scheme shall be - Red, Blue and Black.
